Co-Chair L. Sullivan called the meeting to order at 3:32 p.m.
The following items were discussed and /or actions taken:

1.) Checked book fair date to make sure there were no conflicts, decided upon date 4/18-4/25, Mrs. Whitman's concern is that Reading 3D opens on the 26th so this could be difficult for her so she may want to close on the 22nd instead Book Fair Dates

2.) From Angela Hanners at Accredited Schools Online (through Peggy Bayne):
